## OKANAGAN VALLEY SUMMER STUDENT JOB OPPORTUNITIES

The Okanagan and Similkameen Invasive Species Society (OASISS) is a non-profit organization comprised of an Executive Director and a Field Operations Manager, a board of Directors and a diverse membership that represents different agencies, ministries, conservation organizations and natural resource companies within the Okanagan-Similkameen. The society and its members are dedicated to working together to prevent, monitor and control the spread of invasive species in our region. OASISS is currently seeking four enthusiastic, self-motivated, articulate and organized individuals to join our team!

### **Invasive Plant Program Assistant (one position)**

Term: Full time, May 22 - August 25, 2019 (14 weeks)

Base location: Penticton

Wage: \$15 per hour

### **Aquatic Invasive Species (AIS) Program Assistant (three positions)**

Term: Full time, May 22 - August 25, 2019 (14 weeks)

Base locations: Penticton, Kelowna and Vernon

Wage: \$15 per hour

Closing: May 3, 2019 @ 5:00 PM

#### **Work Tasks and Responsibilities:**

- Follow weekly workplans and attend bi-weekly staff meetings
- Identify and record locations of invasive plants
- Collect and release biological control agents, natural insect enemies
- Hand pull, cut, dig and dispose of invasive plants in priority locations
- Need for daily communications and updates to managers and partnering jurisdictions
- Data entry
- Broadcast (hand) seeding of disturbed soils
- Set up a display panel and information at various community events
- Distribute outreach materials to retail outlets, municipal offices, and local businesses
- Provide landowners with information on invasive plant identification and management
- Report writing

#### **Work Tasks and Responsibilities:**

- Create weekly workplans and attend bi-weekly staff meetings
- Interact with recreational boaters at boat launches and provide information on aquatic invasive species
- Deliver outreach materials to yacht clubs, retail outlets, boat rental facilities, at boat shows and community events
- Speak with visitors at provincial parks and campsites, youth at summer camps and other locations identified throughout the duration of the project
- Set up a display panel and information at various community events
- Conduct surveys for aquatic invasive species in key locations identified by experts
- Report writing

## **FOR ALL THE POSITIONS**

### **To be eligible to participate in the Canada Summer Jobs initiative, individuals must:**

- be between 15 and 30 years of age at the start of the employment;
- be a Canadian citizen, permanent resident or person to whom refugee protection has been conferred under the Immigration and Refugee Protection Act; and
- be legally entitled to work in Canada in accordance with relevant provincial/territorial legislation and regulations.

### **Requirements for the jobs:**

- Must be available to complete the full work term
- Must have completed at least one year of post-secondary education and ideally is pursuing a post-secondary education in the field of natural sciences
- Must provide own work space; each employee works and is based from their own 'home office'
- Must be able to access, assimilate and organize information from emails, digital files (Excel, Word, PPT, PDFs, shared files), maps, literature and discussions on a daily basis to complete all tasks competently
- Must be able to work independently and maintain own work schedule
- Must have a reliable vehicle– compensation for mileage will be provided at the current government rate (log book required) based on a pre-determined marshalling point
- Required to work a flexible 40-hour work week (aquatics students will work most weekends and some evenings) for the full work term
- Students must provide their own computer, cell phone (stipend provided) and personal outdoor work gear, including items such as: sturdy work boots, rain gear and sun protection. Personal protective safety gear will be provided by the employer as required for any specialized tasks

### **Preference for a strong combination of the following skills:**

- Proven ability to engage people in conversations
- Excellent written and oral communication skills
- Experience working on or around water and boats, including angling [for the Aquatics positions]
- Experience with or knowledge of invasive species
- Ability to travel and work in variable environmental conditions

### **HOW TO APPLY:**

- Submit a cover letter (optional) and resume (mandatory) in one single document. **Please ensure this document clearly shows how you meet the mandatory requirements.**
- **Indicate which position you are applying for: Invasive Plant Program Assistant or AIS Program Assistant**
- **For the Aquatic positions, please indicate which Regional District is your preferred placement - South Okanagan-Similkameen (Penticton), Central Okanagan (Kelowna) or North Okanagan (Vernon).**
- Only applicants who have been selected for the interview process will be contacted.
- Applications will be accepted until **5:00 PM Friday, May 3, 2019.**
- Interviews will take place in early May
